Accept September Minutes - Samantha Young motioned to accept, Adam Schatz seconded. Unanimously accepted.

Wallum Lake- Lake level at 585.5 Reported by Paul. Dam area looks clean, no litter. The paths have been cleared of trees, signs are cleared of obstruction.

Lake residents brought discussion on Wallum Lake study of 2020 Suggested better communication between dam operators or have one dam operator for all dams.

Recent well contamination with heavy rains reported for some Wallum Lake residents because of high lake levels.

Town Conservation Plan- Roberta Lacey contacted Norma O'Leiry to talk about Thompson Connecticut Conservation plan for ideas and suggestions for developing Town plan.

Nipmunk Trail- Monique reported kiosks updated with DEM posters and new maps. Cleared the trails of fallen trees. Ron and Michael made a bog bridge near river to make trail passable for hike on Saturday. No hunting signs go up at the end of October.

Quarterly Conservation Programs- Nipmuc hike last week was a successful event.

Tuesday Dec 26 Full Moon Hike at Branch River Park scheduled 6-8pm. Dr. Clarkson November 28th at Jesse Smith Library- Will discuss: threats to birds, climate change, pesticides. Dr Clarkson is Audobon Director of Aviary research.

Lapham Farm- Samantha reported need to clean up barbed wire and trash on some trails. Samantha developed a letter for residents bordering property explaining plan for trail system. Cleanup scheduled for Sunday at 9.

Branch River Park- Clean up Purple trail over the winter. Some other water bars on steep trails, rails in bridges.

Lodge trails- Nice walking trail. Wide trail and bridges.

Duck Pond- Kiosk underway. Tree's down need to be cleaned up. October 28 at 9am.

Canoe Launch- Ron is working on Town of Burrillville list of canoe launches for visitors and residents. Micheal will draft a letter asking about access to boat launch for canoes behind Assembly Theatre.

Union Pond- Plan to open/clean trails when vegetation dies this winter. Need to put up boundry markers.

Rt 102 Gateway - Ron cleaned up trash, tree limbs, brush.
