## Amendments to Zoning Ordinance, Development Regulations, and Comprehensive Plans Regarding 2023 Legislative Acts and Recommendation to Town Council.

Consultant Jeff Davis of Horsley Witten reviewed a memo from Ursillo, Teitz & Rich, Ltd dated 11/27/23 detailing their legal interpretation of RIGL inclusionary zoning law "P.L. 2023, ch 302 & 303". After careful review, consideration and lengthy discussion, the Board was of the opinion that maintaining their recommended repeal of Inclusionary Zoning Sec. 30-164 reasoning that Rhode Island General Assembly enabling legislation as written puts the Town at an increased risk of falling below the 10% LMI rate. The Board was of the opinion that legislation quadrupling of the number of bonus market rate units for each created affordable is unsustainable. Consultant Jeff Davis recommended the Board participate in RI Housing MTAP online training to review RIGL legislative changes that are effective 1/1/24. Review of Subdivision and Land Use Regulations will occur at the January 8, 2024 meeting.
